## Thornicrofts of North Rode

North Rode is a small area in the south of the parish of Prestbury, adjacent to Gawsworth on the north and Buglawton & Congleton on the south. Historically as part of Prestbury it used Gawsworth for baptisms and burials and also the church at Bosley but records are incomplete, possibly due to the distance from either church and also to loss of Bosley records. North Rode did not have a church until 1846 after which it has its own registers. Adjoining it on the west is the equally small parish of Eaton, again without a church, which is part of the parish of Astbury. This therefore results in baptisms, marriages and burial from Eaton being performed at the historic church of Astbury situate about four miles to the south of Eaton.

Prior to 1588 the manor of North Rode was owned by Robert ffulehurst, who for several years had been disposing of parts of the manor. In 1589 Sir Christopher Hatton, Lord Chancellor of England purchased North Rode from him and granted new leases there. He retained the manor until 1627 when he fell from favour and sold the manor to the historic Crew family of Crewe Green. Their papers, now at Chester Record Office preserve the leases which Hatton and later the Crewe's granted to their tenants. These were granted for a term, usually for two or three lives (generations) of the family and name the leasee, his wife, sons and their wives and grandchildren so providing a valuable source of data to be correlated with the Parish Registers.

Leases commence in 1589 and in 1629 a rent roll names nineteen tenants in the manor. Of these there are four named Smallwood, two each of Pass, Stubbs, Lowndes and Thornicroft and one each of Davenport, Wilkinson, Burgess, Gandy, Parkington & Parnell. These established families, particularly those with more than one lease show that they have been at North Rode for a considerable period and their established tenure is shown by the dates of renewal of leases.

At the renewal of the Thornicroft leases in 1589 they were granted 'upon the surrender of former leases' indicating earlier settlement at North Rode and therefore it is probable that they are descended from a branch of the original Siddington family although no documentation has been found.

Thornicroft of North Rode. When Sir Christopher Hatton took possession of the Manor of North Rode in 1589 he renewed the leases to the tenant farmers which earlier had been granted by Robert Ffullehurst and some by Sir Edward Fitton of Gawsworth. These however are not at Chester Record Office and their collection of leases comes from the papers of the Crewe family who purchased the Manor in 1627.

Lease 1.12.1589 'to Robert Thornicroft, husbandman, in consideration of the surrender of a lease with a term of years to run and in one messuage, certain lands tenements & hereditaments, for a fine of £40, £20 to be paid before and £20 after signing.' The lease is for 80 years, with Ellen, wife of said Robert, William (son bp. 1569) and Nicholas, sons of said Robert or anyone of them shall be long lived. The rent was 21/10 per year, heriot was best of goods & chattells. Suite was to be paid to the Mill of Sir Chris. Hatton by grinding corn there. It was lawful to grub shrubs and rid all shrubs, gorse, byres, brambles, broom, sloes and brute now growing, also to make a marl pit.

Robert was bur. 19.6.1605 and Ellen on 20.12.1599. William (1) was bp 22.7.1569 and married Margaret Smallwood on 30.6.1589 at Prestbury. His brother Nicholas was bur. 2.5.1600 and sister Margery on 5.10.1593. Margaret died on 2.6.1617.

A similar lease of the same date was signed with Edward Thornicroft, son of Nicholas who was buried on 5.4.1578, with Frances, wife of Edward and Margery, widow of Nicholas. The fine was £28 and the annual rent 10/-, the term being for 80 years. The terms are similar to the lease to Robert and a covenant forbidding 'taking any inmate to dwell or abide in the said messuage' by Robert, his wife their child or children without 'the special consent' of Sir Christopher Hatton. Edward was buried 11.3.1625 and his widow Frances on 2.9.1646.

There are no children of Edward & Frances recorded.

Children of William Thornicroft (1) bp. 22.7.1569

William (1) & Margaret (Smallwood) had six children bp & bur. at Gawsworth

William (2) bp 11.4.1600 & bur. 13.6.1684. He married Elizabeth -- c 1632 (not found).  
Edward bp 24.3.1604 bur 5.6.1669 at Marton. He left a will in which he leaves 5/- to Isabell Thornicroft (the wife of his nephew William (3), who died 28.12.1670). 20/- to Sarah Thornicroft. She has not been identified. An entry in the Burslem Registers reads:-

'William (of Rode) & Sarah, daughter Mary baptised 2.6.1667 at Burslem.'

Sarah cannot be a second wife of William (2) since his wife Elizabeth is named in a lease of 1668 and in the same lease William (3) wife is named as Isabell (bur 28.12.1670).  
He leaves William (2), his brother 5/-.  
His house at Marton together with its contents is left to his nephew, William (3).  
William (2) bp 1684, left a will which is recorded at Chester Record Office but is missing

On 4.3.1630 William (1) yeoman, & William (2) surrendered 'the former lease of 1589' of 'William the elder & father of the said William' & presumably a new lease was taken.  
On 9.10.1668 the lease of 1630 was surrendered and a new lease signed for the lives of William (2) his wife Elizabeth, his son William (3) & Isabell his wife and grandson William (4) 'son of the last mentioned William'

William (4) is named in the lease of 1668 but bapt. not found He married Mary Smallwood at Prest. 12.1.1686/7 and was buried on 23.12.1730. Mary buried 14.11.1731.

Under the terms of the will of William (2)'s brother Edward who did not marry and died 5.6.1669, his house at Marston and its contents are left to his nephew, William (3) and 4/- each to the four children of William (3). The fourth child 's baptism has not been found but he is Mathew who was a witness to the signature of his brother William (4) when he signed a new lease in 1704. In 1708 Mathew is the tenant of property in Eaton which is being sold by Henshaw of Henshaw Hall, Siddington. Mathew is significant as the progenitor of the Thornicrofts of Gawsworth and elsewhere in the 18th to 20th centuries,

Lease of 4.1.1704. between Anne Crewe Offley and William (4) surrendered the lease of 1668 'whereon two lives are yet in being' These are William (4) and Mathew. It was to William (4) and his son William (5) and also to William & Richard Smallwood, presumably relatives of his wife Mary Smallwood.

It was for a location known as 'Cromwell' near a bend on the River Dane in N.Rode with a fine of £90 at a rental of 36/8 per year. This is the rent in a lease for Cromwell in 1629 to Humphrey Smallwood and may indicate the the Thornicroft's had moved to Cromwell.

Children of William (4) & Mary.

William (5) baptism not found but c 1687/8. He married Elizabeth Dawson at Prestbury on 2.2.1724 and had died by 1755 but place not known. Elizabeth is buried on 10.12.1755 'Widow of Wm Thornicroft John bur.18.10.1689. John bur. 16.12.1698

The lease of 1704 was surrendered by William (4) on 4.10.1729 a year before his death on 23.12.1730 and on 21.10.1729 a new lease to William (5) 'the younger' at a rent of £25 per year. is signed.

On 29.10.1731 a lease was signed between John Crewe and Henshaw Stubbs for 'that messuage commonly called Thornicroft tenements late in the holding of William Thornicroft deceased' at a rent of £20 per year.

William (4) is named in the Poll list of 1722 as a freeholder on N. Rode and this may be land which is named in 1805 and in the possession of Thornicroft's of N.Rode.

There are probably two further sons, William whose baptism, marriage & burial have not been found. He could be the father of four children baptised in 1757, 1759 & 1762 and one buried 1767. John (1) baptism not found, married Ann Slater on 4.9.1670 and had nine children

The established farming life of the Thornicrofts of North Rode from pre 1560 to the mid 18th cent. with the succession of five Williams as heads of the families begins to disrupt about 1730 with the lease of the Thornicroft tenements out of the family & their association with 'Cromwell'. William (5) after an apparently normal life to 1730 suffers the loss of two sons in January 1736/7 is not found in the registers or his burial(before 1755). In June 1767, Thomas Thornicroft, a wheelwright living at North Rode, but of the Macclesfield branch of the Thornicrofts died intestate and his estate was administered by his sister Elizabeth Johnson of Macclesfield (see page 51). An inventory of 10.7.1737 includes "Apparell to Thomas Dawson ( probably the brother of Elizabeth, wife of William (5) value £1.4.4. & goods to value £6.3.2½ for William Thornicrofts children". This gift probably indicates the needs of the five surviving young children of William (5)

He spent nearly 30 years in retirement with interests in collecting books and art, living during this period at 'Woodland View' in Brook St.
